HELP US SUPPORT MORE CAUSES

As the Strategic Solutions Community Foundation enters its 6th year, we continue to grow and help more and more causes. On behalf of the Community Foundation and everyone at Strategic Solutions, we'd like to say a massive thank you to all those involved, and the causes themselves for doing such fantastic work in the community.

The more money we can raise, the bigger impact we can have! Three ways you can help us with that follow.

1. Leave a legacy

Many people consider leaving money to charity in their will. As well as making a huge difference to the charity, leaving a gift this way can also be efficient if Inheritance Tax (IHT) is due on an estate.

That's because gifts to UK registered charities are exempt from Inheritance Tax. As an officially registered charity, we would love to be considered as a beneficiary!

What is Inheritance Tax?

Inheritance Tax (IHT) is charged at a rate of 40% on estates that exceed any allowances The available. main allowance is the 'Nil Rate Band', which is £325,000. There currently additional allowance of £175,000 called the 'Residence Nil Rate Band', which is available if certain conditions are met, including leaving the property to a direct descendent. addition. In unused allowances inherited be by can surviving spouse or civil partner.

An example

Mr Barrel's estate is worth £525,000 when he dies. In his case, he has both the Nil Rate Band and Residence Nil Rate Band available. The excess of £25,000 over these allowances is subject to Inheritance Tax. At 40%, this would equate to £10,000 being owed to HMRC.

However, if in his will, Mr Barrel included charitable gifts amounting to £25,000, this figure would be subtracted from the taxable value of his estate, meaning no Inheritance Tax is due.

That not only makes a big difference to any charities that benefit but also helps with the administration of the estate. That's because Executors would need to pay any Inheritance Tax before the estate can be distributed.

There's more – reducing the IHT due with the "10% rule"

Furthermore, leaving a gift of 10% or more of the net estate value (in simple cases, the estate minus the nil rate band) to charity can reduce the rate of Inheritance Tax payable from 40% to 36%.

Where would the money go?

At the Strategic Solutions Community Foundation, we generally target smaller, local charities and organisations, but if given a more specific wishes, the trustees would look to honour this wherever possible.

2. Shop through Easyfundraising

Another way you could help is via Easyfundraising.

They partner with over 8,000 brands and will donate part of what you spend to a cause of your choice (including the Strategic Solutions Community Foundation!) if you click through their website or app to take you to the brand's website. It won't cost you any extra. The cost is covered by the retailer. You can sign up using the link or QR codes below.

3. Donate via Kindlink

Last but not least, we have an online donation portal via Kindlink, which allows one-off or regular donations at the click of a button.

Donations can be made through Gift Aid, enabling us to claim an extra 25p for every £1 you give, at no extra cost (as long as they're not more than 4 times what you have paid in tax in that tax year). If you are a higher or additional rate taxpayer, you can claim tax relief too!
